M_o_R® Foundation & Practitioner Exam Information

This course includes 2 exams; the M_o_R® Foundation Exam and the M_o_R® Practitioner Exam. The M_o_R® Foundation exam is taken on the third day while the M_o_R® Practitioner

exam will be taken on the fifth and final day of the course.

The Foundation exam:

- 75 multiple choice questions
- 5 questions are trials and are not counted towards the final score
- 1 hour in duration
- Closed book
- 50% required to pass

The Practitioner exam:

- Objective testing. This is a type of multiple choice
- 4 questions, each worth 20 marks
- 3 hours in duration
- Open book
- 50% required to pass
